## TEACHING RESPONSIBILITIES

<u>Professional Practice Expectations I</u> (Professional Socialization) is designed to assist the student as they assume the role of professional, both as a student in an educational program and ultimately as a provider functioning effectively as a member of the health care team. The student will be introduced to the core documents governing the profession, the professional organization and the role of advocacy, generic abilities/professional behaviors and the assessment and organizational skills necessary for successful practice. 1 credit

<u>Professional Practice Expectations II</u> (course coordinator) (Professional Socialization) is designed to increase the student's awareness of interactions with clients and colleagues in the healthcare system. As a result of this course, the student will become more aware of their patterns of communication as well as having the opportunity to practice effective interaction (both oral and written) in a culturally competent manner. This course also examines both the patient's and clinicians response to illness and students are introduced to the concepts of confidentiality and informed consent. 1 credit

<u>Professional Practice Expectations III</u> (faculty) (Teaching and Learning in the Health Care Environment) is designed to assist the student in applying concepts of the teaching learning process to physical therapy practice in a variety of settings (academic, clinical and professional). Students will work in groups to plan, implement and assess the efficacy of several learning activities. 2 credits.

<u>Professional Practice Expectations V</u> (course coordinator) (Legal and Ethical Issues in Healthcare) is designed to provide students with the ethical principles, laws, and rules that regulate and guide the practice of physical therapy nationally and in Georgia. Students will demonstrate application and integration of these guidelines via case studies based on ethical and legal situations frequently encountered in the clinical settings. 1 credit.

Professional Practice Expectations VI (course coordinator) is designed as the capstone of the teaching-learning thread throughout the curriculum. Students design their four week Elective experience during this course as well as prepare for the fall Clinical Education experiences. Students' also critically explore the role of Clinical Instructor (CI) and revisit the assessment and organizational skills necessary for successful practice. 1 credit

<u>Elective (Capstone)</u> (course coordinator). The student will gain knowledge and skills in a physical therapy special interest area by individually defining personal learning objectives and developing learning activities to achieve those objectives. Self assessment, expert opinion and/or peer assessment are utilized to evaluate outcomes of the experience. Study may be in areas related to practice, administration, education or research. 4 credits.

<u>Management</u> (course coordinator). This course is designed to assist the student in the development of managerial skills pertinent to the healthcare environment. Students will apply knowledge of marketing, reimbursement, legislation/regulation, risk management, and quality control to the design and operation of a physical therapy practice. The functions and characteristics of an effective manger will be discussed and practiced. 4 credits

<u>Geriatrics</u> (lab instructor) is a comprehensive, evidence-based overview of physical therapy for older adults, integrating physical therapy concepts, evaluations, interventions and clinical decision making. Students will learn to manage the special needs of the elderly across all health care settings with clinical application of knowledge in caring for the older adult population. Incorporates aspects of fitness and wellness into the rehabilitative model of care with and without pathological conditions. 1 credit.

<u>Professional Practice Expectations IV</u> (course coordinator) (Professional Development) is designed to further facilitate the development of each student as a professional. Groups of students will be involved in advocacy roles in the community and profession. This course provides an opportunity for students to research, present and facilitate a peer discussion on a current issue affecting the delivery of physical therapy services. 1 credit.

<u>Medical Conditions I</u> is designed to provide students with the knowledge and skills necessary to provide appropriate PT interventions based on the examination, evaluation, diagnosis and prognosis of patients with cardiopulmonary and endocrine dysfunction. Wellness and prevention as it relates to cardiopulmonary disease and diabetes mellitus will be studied. Course content will be presented in modified problem/case based format and will include small group study, interactive labs, resource and lecture sessions. 6 credits.

<u>Medical Conditions II</u> (course coordinator) is designed to provide students with the knowledge and skills necessary to provide appropriate PT interventions based on the examination, evaluation, diagnosis and prognosis of patients with peripheral vascular disease, wounds, burns, and infectious diseases. Course content will be presented in modified problem/case based format and will include small group study, interactive labs, resource and lecture sessions. 4 credits.

<u>Medical Conditions III</u> (course coordinator) is designed to provide students with the knowledge and skills necessary to provide appropriate PT interventions based on the examination, evaluation, diagnosis and prognosis of patients with complex medical and surgical problems. Special emphasis will be placed on the patient with multiple medical problems in the critical care unit, the post surgical patient with amputations, patients with obstetrical and gynecological disorders and patients with cancer. End of life issues will be discussed. Wellness and prevention as it relates to the geriatric population will be studied along with PT issues pertaining to the frail elderly population. Course content will be presented in modified problem/case based format and will include small group study, interactive labs, resource and lecture sessions. 6 credits.

<u>Medical Conditions IV</u> (course coordinator). Student groups will work through problems and case studies related to patients with lower and upper limb amputations. Students will address the pathology, impairments, functional limitations and disabilities associated with amputation. Emphasis will be placed on examination, evaluation, intervention and physical therapy diagnosis related to patients with amputations. Content will include (1) all previously learned examination skills such as assessment of sensation, range of motion and strength (2) previously learned interventions such as wound care, post operative care, therapeutic exercise and home programs (3) new examination, evaluation, intervention and physical therapy diagnosis skills related to the patient with an amputation and (4) new information related to prosthetic prescription and prosthetic training. Basic science principles will be integrated with examination, evaluation and intervention. 1 credit.

<u>General Concepts of Patient Management II</u> is designed to provide students with the knowledge and skills necessary to provide appropriate general interventions based on the examination, evaluation, diagnosis and prognosis of patients. Topics will include principles of therapeutic exercise, modalities and introduction to other physical therapy interventions. Course content will be presented in a modified problem/case based format and will include small group, interactive labs, resource and lecture sessions. 3 credits

<u>Freshman Seminar</u> (course coordinator) introduces the student to the field of physical therapy. Students will be challenged to explore the history, environment, trends, and future of the physical therapy profession. Students learn about their own work orientation and learning style. Emphasis is on developing successful study skills, time management ability, and professionalism. Students will be oriented to the expectations/responsibilities of those enrolled in the Physical Therapist Assistant Program. 0 credits

Introduction to Physical Therapy (course coordinator) introduces the PTA student to many aspects of physical therapy including the PT/PTA relationship, communication, the history of physical therapy, the APTA, scope of practice, ethics and values, laws and standards affecting physical therapy, health care team roles, professional development, evidence-based practice, cultural competence, documentation, liability and confidentiality. Students are exposed to basic administration principles, problem solving methods, and continuous quality improvement. Students learn universal precautions. Students are introduced to transfer training, gait training and wheelchair training. They also learn about their own work orientation, learning style and the Core Values. 3 credits.

<u>Pediatrics</u> is designed to provide students with the study of human development with emphasis on children under five. The primary emphasis will be on the assessment, evaluation, diagnosis, prognosis and intervention in children with neuromusculoskeletal disorders. Students will be expected to use this information to develop interventions to meet patient centered goals. There will be a variety of learning experiences used in this course. 4 credits.

<u>PTA Principles and Procedures 1</u> (course coordinator). Students are instructed in the application of therapeutic exercise, therapeutic modalities, wheelchair training, and identification of architectural barriers/environmental modifications. Students learn to apply and teach proper posture, body mechanics and lifting techniques. They also receive training in universal precautions, positioning and draping, transfer training, gait training, balance training, and applying therapeutic heat and cold. Students learn how to document services rendered, how to participate in discharge planning, how to provide psychosocial support, and how to educate patients and families. Emphasis is placed on communication skills and ethical practice. Successful completion of the competency checklist is required to pass this course. 3 credits

<u>PTA Principles and Procedures 2</u> (course coordinator). Students receive instruction in basic physical therapy assessment skills including goniometry, manual muscle testing, vital signs, flexibility, sensation, reflexes, segmental length, segmental girth, segmental volume, endurance, pain, balance, and activities of daily living. They are also introduced to industrial medicine assessments. Students receive further instruction in psychosocial support, patient/family education, ethics, communication, and documentation. Successful completion of the competency checklist is required to pass this course. 4 credits.

<u>Clinical Education 1</u> provides the student with a full-time, four-week clinical experience. 4 credits.

<u>PTA Principles and Procedures 3</u> (course coordinator). Students learn the rehabilitative process for patients who present with neurologic, pediatric/developmental, cardiopulmonary, chronic disease, wounds, and other disorders commonly seen in physical therapy. Students receive further instruction in psychosocial support, documentation, ethical behavior, patient/family education, and communication. This course runs concurrently with PTA Principles and Procedures 4. 4 credits.

<u>PTA Principles and Procedures 4</u> (course coordinator) provides laboratory instruction for the assessment and treatment of patients who present with neurologic, pediatric/developmental, cardiopulmonary, chronic disease, and other disorders commonly seen in physical therapy. Students learn the developmental sequence and how it applies to treatment and learn advanced therapeutic exercise techniques. They also receive further instruction in psychosocial support, documentation, ethical behavior, patient/family education, and communication. Successful completion of the competency checklist is required to pass this course. This course runs concurrently with PTA Principles and Procedures 3. 4 credits.

<u>Applied Kinesiology</u> (course coordinator) covers neuromusculoskeletal anatomy and physiology in depth. Students are introduced to the analysis of human movement based on knowledge of neuromusculoskeletal anatomy and physiology. 3 credits.

<u>Clinical Education 2</u> provides the student with a full-time, seven-week clinical experience. 6 credits.

<u>Clinical Education 3</u> provides the student with a full-time, seven-week clinical experience. 6 credits.

<u>Professional Issues Seminar</u> (course coordinator) is designed to provide the student with additional information in conjunction with their full-time affiliations. Topics may vary depending on issues raised by students while in the clinic. Topics may include: licensure, teaching methods, research, documentation, advances in the field, changes in legislation, insurance issues, etc. Student will also receive assistance in preparing for their state boards. 1 credit.

<u>Independent Study in Physical Therapy</u> (course coordinator) is designed to allow students further study in physical therapy. The material covered may be either remedial or advanced study. The course is individually designed by the PTA faculty to meet the specific educational needs of the PTA student. 1 - 3 credits.
