Overall Goal of FMIS Rotation:

To admit, evaluate, and treat adult hospitalized patients 18 years and older with appropriate consultations from the AU Family Medicine Clinic, outpatient transfer, or the Emergency Department.

Description of FMIS Rotation:

The Family Medicine Inpatient Service (FMIS) rotation is required during the Family Medicine Residency training program. This rotation occurs at the WellStar MCG Health Hospital in the general medicine wards. Other units and nursing staff may be used as necessary.

This hospital service receives all admissions from the AU Family Medicine Center, affiliated AU community family medicine practices, and Georgia War Veterans Nursing Home (non-VA-designated patients). Unassigned patients may also be admitted through the ER if the census is not capped. Overnight admissions come through the ER only. Residents are responsible for caring for patients admitted for general medical problems. In addition, patients may be transferred to the FMIS from the CCU, ICU, or other services for appropriate general medical care.

The family medicine resident serves patients with general internal medicine problems. The Family Medicine resident is responsible for higher-acuity service patients with general internal medicine problems. Informal and formal teaching is provided by the upper-level resident and hospitalist or faculty attending.

Clinical Teaching, Faculty Role Modeling, Case-Based Teaching, Supervised Clinical Management, Didactic, Guided Research

Research / Scholarly Requirement for FMIS Rotation:

- Participate in quality assurance (QI) and research activities as directed by the FMIS core faculty and department during the rotation
- Develop a presentation to give in one patient safety conference (formerly M&M) after the completion of the rotation

<u>Procedures / Skills Taught in FMIS Rotation:</u>

Multiple procedures and skills are taught during the FMIS rotation depending on credentials of the attending physicians. Procedures and skills may include but are not limited to: paracentesis, thoracentesis, arterial blood gas (ABG), radiographic interpretation, ECG reading, and joint aspirations and injections.

Assessment Methods for FMIS Rotation:

Direct Observation, Procedure Evaluation, End of Rotation Evaluation, Chart Review, Evaluation of Journal Club, Procedure Log, Case Lob, Direct Feedback

Osteopathic Resident Evaluation for FMIS Rotation:
