Dear Student,

As part of the National Council for State Authorization Reciprocity Agreement (NC-SARA), Augusta University is required to notify all prospective and currently enrolled students whether they would be eligible for licensure and/or certification in their home state upon completing their Augusta University degree program. The Pamplin College of Arts, Humanities, and Social Sciences, Department of Social Sciences, Bachelor of Social Work Program anticipates that graduates of this program may seek state licensure as a Licensed Baccalaureate Social Worker, Licensed Social Worker, Licensed Social Worker, depending on their state of residence.

The Bachelor of Social Work Program has determined that the required classes and educational activities of this academic program, which is accredited by the Council on Social Work Education (CSWE), will fulfill the educational requirement for licensure in all states that offer licensure at the bachelor's level. Each state/province has unique requirements to attain licensure, but all require a bachelor's or master's degree in the field from a CSWE-accredited program. Many require passing the Association of Social Work Boards (ASWB) Examination. Some jurisdictions have other requirements, and most require supervised practice after the degree is awarded. Licensure is not required to practice social work in all states. The Bachelor of Social Work Program at Augusta University is accredited by the CSWE. The states where licensure requires more than a BSW include: California, Colorado, Connecticut, Florida, Georgia, New York, Rhode Island, Vermont, and Washington. The program continues to work to gain verification that our program meets licensure requirements in America Samoa but has listed them as not meeting the requirements until verification can be obtained.
