DEFINITIONS

Half-Time

Enrollment is 6 semester hours for undergraduate students and 5 semester hours for graduate/professional students.

<u>Free Application for Federal Student Aid (FAFSA)</u>: All students are expected to contribute towards the cost of their post-secondary education. The FAFSA is the application used by the U.S Department of Education to determine the student's Expected Family Contribution and to conduct a needs analysis. The FAFSA is used by the Office of Student Financial Aid to determine eligibility for federal, state, institutional, and private grants, scholarships, loans, and any other applicable laws.

Regular Student

As defined by the Federal Department of Education, a regular student is someone enrolled or accepted for enrollment at an institution for the purpose of obtaining a degree, certificate, or other recognized education credential offered by the institution.

Selective Service Registration

Selective Service Registration is for the military draft. It is required by law for male individuals to register upon reaching the age of 18. Male students who are U. S. citizens must meet the federal guidelines for selective service registration, as a requirement for receiving state student aid. Refer to www.sss.gov.

Satisfactory Academic Progress

To receive funds administered by the Financial Aid Office at Augusta University, students must be making measurable academic progress toward completion of an eligible degree or certificate program. Federal regulations require evaluation of both quantitative and qualitative academic progress.

PROCESS & PROCEDURES

All students who have been accepted for admission to Augusta University and who wish to apply for financial aid must meet certain eligibility requirements as specified by the U. S. Department of Education, the Georgia Board of Regents, Augusta University, and other applicable agencies.

Academic Eligibility Requirements:

- 1. Students must be enrolled in a degree- program at Augusta University.
- 2. Students must be making Satisfactory Academic Progress.
- 3. Students must be enrolled at least half-time to be eligible to receive federal loans through the Direct Loan Program.

Federal Eligibility Requirements:

- 1. The student must be a U. S. citizen or eligible non-citizen.
- 2. The student must have a valid Social Security Number (exceptions may apply for a student from the Republic of the Marshall Islands, the Federated States of Micronesia or the Republic of Palau, or an eligible non-citizen).
- 3. The student must have a high school diploma, a General Education Development (GED) certificate, or have been home-schooled with a secondary school completion credential, or have passed an exam approved by the U.S. Department of Education.
- 4. The student must be enrolled or accepted for enrollment as a regular student and working toward a degree or certificate.
- 5. The student must not owe a refund on a federal grant or be in default on a student loan.
- 6. The student must demonstrate financial need except for Unsubsidized Federal Direct Loans.

Office of Student Financial Aid Application Process:

Application Procedures:

- 1. Students who wish to apply for financial aid must complete the Free Application for Federal Student Aid (FAFSA) at www.studentaid.gov.
- The Office of Student Financial Aid will process student applications and determine eligibility.
- 3. Student award letters will be available on their POUNCE account once applications have been processed.
- 4. Students must complete a FAFSA each year beginning on or after the appropriate date published by the Department of Education at www.studentaid.gov.
