



## Parking Guidelines for Students Living in On-Campus Housing | 2021-22

*Please find parking information below based on student type and residence hall. If a category has more than one lot listed, the student has the option to select either parking location. If only one location is listed, that is the required parking assignment for that student at that residence hall.*

### **MCG | DCG Students @ Elm Hall**

- Lot 1 @ Elm Hall [\$275 per semester]; in-person at the parking office
- Lot 38 Remote – [\$75 per semester]; on-line at [augusta.aimsparking.com](http://augusta.aimsparking.com)

MCG | DCG students living at Elm do not have access to other lots on the health science campus. Students can park in non-reserved spaces at Summerville and Christenberry Fieldhouse. Permits are active July 1 to December 31, and January 1 to June 30.

### **Graduate, Transfers & Returning Undergraduates @ Elm Hall**

- Lot 1 @ Elm Hall [\$250 per semester]; in-person at the parking office
- Lot 38 Remote – [\$50 per semester]; on-line at [augusta.aimsparking.com](http://augusta.aimsparking.com)

Graduate, Transfers & Returning students living at Elm do not have access to other lots on the health science campus. Students can park in non-reserved spaces at Summerville and Christenberry Fieldhouse. Permits are active August 2 to December 31, and January 1 to May 15.

### **Transfers & Returning Undergraduates @ University Village**

- University Village Parking Lot – [\$50 per semester]; on-line at [augusta.aimsparking.com](http://augusta.aimsparking.com)
- Cyber Center Parking Deck – [\$250 per semester]; in-person at the parking office

Students can park in non-reserved spaces at Summerville and Christenberry Fieldhouse at any time. **Transfers & Returning students living at University Village must use Health Science Campus Lot 38 between 7 am and 4 pm, Mon-Fri.** Permits are active August 2 to December 31, and January 1 to May 15.

### **First-year Students @ Oak or Elm Hall**

- Lot 38 Remote – [\$50 per semester]; on-line at [augusta.aimsparking.com](http://augusta.aimsparking.com)




First-year students living at Oak or Elm Hall are supported by a robust transit system between all four Augusta campuses. First-year students who bring a vehicle to campus will be assigned to Lot 38. Housing students do not have access to park on the health science campus between 7 am and 4 pm, Mon-Fri. A direct shuttle from the Student Center to Lot 38 operates Mon-Fri during afternoons and evenings. Semester permits are active August 2 to December 31, and January 1 to May 15.

As space is available, first-year students may submit an appeal for access to Lot 1. Appeals are accepted beginning August 1. Appeals are only accepted with [notarized] documentation of health issue, military or family-care obligation, university commitment, or off-campus employment. All appeals are reviewed by the Dean of Students or their designee. Assignment to Lot 1 cannot be guaranteed. Upon approval, the fee for Lot 1 is \$250 per semester. ### Additional Information

1. Permits must be renewed each semester.
2. All parking fees are point-of-sale transactions and are not applied to a student's POUNCE account.
3. The AU Transit system uses the Passio-GO mobile app for schedules and on-demand requests.
4. Students living in on-campus housing are permitted to use non-reserved parking on the health science campus during the following times: weekends, university holidays or overnight between 4:30 p.m. and 7 a.m. Please note that citations will be issued for parking out of zone during restricted hours, and booting/towing will occur for parking in a reserved or otherwise restricted space.
5. Your permit is tied to your vehicle license plate. Should you bring a different vehicle to campus, please update your information in the Parking Portal at least 24 hours in advance.
6. When parked, your vehicle license plate must be visible from the drive lane. Backing into or pulling through a parking space is prohibited. Warnings will be issued for being improperly parked, with repeat violations resulting in a citation. Patrol and enforcement is done through license plate recognition, and we must be able to easily scan your vehicle plate.
7. Students may park in any lot or space unless signs are posted stating otherwise (For example, Reserved Space, AU Service Vehicle, Accessible (handicap), Patient or Hospital Visitor Lots/Spaces, Volunteer, or Official Business Permit required). Parking on a city or campus street or parking on a yellow curb is prohibited at all times.
8. Students MAY NOT PARK in decks/lots reserved for patients, families or visitors. Should a student be a patient or patient guest, please utilize the Courtesy Permit form available on the parking website.
9. Parking violations – including parking on the Health Sciences Campus during restricted hours - may result in a citation, immobilization [boot] or having the vehicle towed at the vehicle owner's expense. Citation notices are issued via email to your augusta.edu account.
10. Residential parking permits are not refunded or pro-rated for any reason.
